Caudill's, on the other hand, proposes that the behavior of a trial court is governed by the "maximum discharge" of the authority given it by the constitution and by the rules of the supreme court in exercise of that authority. In our experience, the trial court's practices in sentencing have fallen in that middle ground, as the trial court ruled that he would not impose the death penalty in one case and then, in another, stated that he could not conceive of any circumstance in which he would not do so. The ultimate authority as to the exercise of the "maximum discharge" of the broad power given to the trial court to punish for capital murder is the Supreme Court, which has ruled that the death penalty may be imposed only for the most aggravated types of murders. We do not think that a trial court in one case can deviate from that practice by its statement that it would not impose the death penalty. A trial court cannot subvert its authority in imposing a sentence of imprisonment for capital murder in a case in which the death penalty was not imposed. Therefore, the trial court in this case committed no reversible error in sentencing this appellant. 7 CONCLUSION The trial court did not err by overruling the appellant's objections to the portions of the jury instructions at the guilt-innocence phase that were separated by the phrase "unless you find them not applicable." The trial court did not err by denying the appellant's motion for mistrial because of the repetition of the word "if" at the penalty phase.
